## Report from the President of the Medical staff and the Chief Medical Officer

With the completion of the Building Towards the Future (BTTF) project and campaign, our provider team is enjoying the new facility and the opportunities it has created for cohesive and collaborative patient care. By having many of our primary care providers and specialists together on the second floor of the new building we are able to confer more easily and respond effectively to the needs of our patients.

Our Hospitalist program, which is now 24/7, plays a significant role in the quality of care we offer to our inpatients. The Hospitalist team of Gregory Curtis, MD, Stephen Bissah, MD, Adnan S. Khan, MD, Steven W. Powell, MD, and Ashwin Swami, MD provides comprehensive, consistent inpatient care, coordinating this care with the patient's primary care provider. This has led to improved patient care and shorter stays in the hospital for patients.

The BTTF project also allowed us to unify our campus and we were very pleased to welcome the New London Pediatric Care Center providers and staff back to the campus in newly renovated space. Drs. Sarah Lester, James McGuire, Tara Thurston, and Aram Kalpakgian, PA-C specialize in pediatric and adolescent healthcare for the Kearsarge/Lake Sunapee Community.

In addition to the New London campus, we continued to provide quality primary care at the Newport Health Center and the New London Family Care Center at Grantham. We know that the access to primary care at these locations is more convenient and timely for patients.

We recognize that healthcare is changing rapidly. With the implementation of electronic medical records in all our locations we believe we will be better able to improve care for our patients, communicate more effectively with specialists and share patient information quickly when needed. The goal of the Medical Staff of New London Hospital is to work each day to respond to our patients and the healthcare needs of our community.

# A Message to the Community

Thanks to you, our physicians, staff, volunteers and Board leadership, our hospital continues to provide quality patient care to our community. This year we celebrate many significant accomplishments from the completion of our building project to the overwhelming generosity of the community that made our capital campaign so successful. New London Hospital continues its proud service to our families and friends in the towns of Andover, Bradford, Croyden, Danbury, Elkins, Goshen, Grantham, Lempster, New London, Newbury, Newport, Springfield, Sunapee, Sutton, Washington, and Wilmot.

We are pleased to share these notable achievements of our recent fiscal year, which ended on September 30, 2009.

- Throughout the two-year construction period, the hospital maintained its focus on patient care, often moving services to a temporary location in order to continue to care for patients. Our patients were always our priority and we appreciate the community's patience with parking challenges and changing directions within the hospital!
- The Building Towards the Future project resulted in all private inpatient rooms, new space for our providers, centralized patient registration, expanded services for specialists such as Concord Orthopaedics, a new rehabilitative and sports medicine area, new and expanded clinical space for pain management, oncology services and the Coumadin program, the return of pediatric services to the hospital campus, and additional parking for patients and visitors.
- Community support for New London Hospital's capital campaign exceeded our goal of \$7.2 million at the end of a unique effort that began with our groundbreaking in August 2007, making our building project possible.
- The volume of our clinical services grew 3.3% over prior year in FY 2009.
- The hospital's provider practices were awarded the NH Immunization Project 2009 Award for Excellence in Clinical Education for the development of a staff manual on immunizations.
- The Barbara Jane Baker Memorial Laboratory again completed a successful survey by the College of American Pathologists.
- The Clough Extended Care Center had a successful state survey and has been designated a 5-Star facility by the Centers for Medicare and Medicaid.
- We continue to ensure that we have quality providers to meet the primary care needs of our patients and we strive to provide the specialty services appropriate for our hospital. Cecelia Vicuna-Keady, APRN, joined the provider team at Newport



Health Center and Lawrence Jenkyn, MD, Neurologist joined the team of hospital specialists.

- Drs. Stephen Bissah, Adnan Kahn, Steven Powell and Ashwin Swami staff the hospital's 24/7 Hospitalist Program, under the leadership of Gregory Curtis, MD, full-time.
- Greg Curtis, MD, was appointed Chief Medical Officer for New London Hospital and director of the 24/7 Hospitalist program.
- Cheryl Fitzgerald, certified chaplain, joined New London Hospital and provides spiritual care services to inpatients, residents of the Clough Center and staff.
- We received a grant in the amount of \$264,000 from the NH Department of Health and Human Services, Maternal and Child Health, to provide enhanced primary care services at the Newport Health Center to Sullivan County residents.
- Partnering with West Central Behavioral Health, we implemented an integrated behavioral health program for Newport Health Center patients.
- The New London Hospital Ambulance Service received the Unit of the Year Award from the State of NH, recognizing exemplary community service. Our 24/7 ambulance service continues to serve the community with financial support from the towns of Grantham, Newbury, New London, Springfield, Sunapee, Sutton, and Wilmot.
- We held our 7th annual Emergency Services Conference at Mount Sunapee Resort, attracting over 400 participants.
- The Hospital continues to implement new modules of its Healthcare Information System and primary care providers are moving to the use of computer tablets as part of the hospital's initiative to use Electronic Medical Records.

- We continue very thoughtful deliberation of the opportunity to create a Continuous Care Retirement Community (CCRC) on hospital land. Surveys and focus groups have been held to determine community interest in this project.
- Catherine Budd joined the management team as senior director of human resources.
- The NH Department of Resources and Economic Development recognized the hospital's building project with a First Class Business Award.
- The 4th annual Grand Gala, 6th annual Golf Tournament and 85th annual Hospital Days, combined with generous community support, contributed to a successful Annual Fund.
- The Friends of New London Hospital volunteers, both in-house and community committee members, came together to ensure that the mission of the hospital was supported through their projects and activities in FY 2009. The combined group of volunteers adds to the heartbeat of the hospital. The new Friends of New London Hospital Gift Shop opened in May, serving patients, visitors and staff with expanded hours. In-house volunteers contributed over 11,482 hours of service representing a dollar figure of \$232,505 to many departments throughout the hospital from the mailroom to the front desk.
- New London Hospital, the provider practices in New London, Newport and Grantham, and the Clough Extended Care Center again combined to produce a positive bottom line for the year.

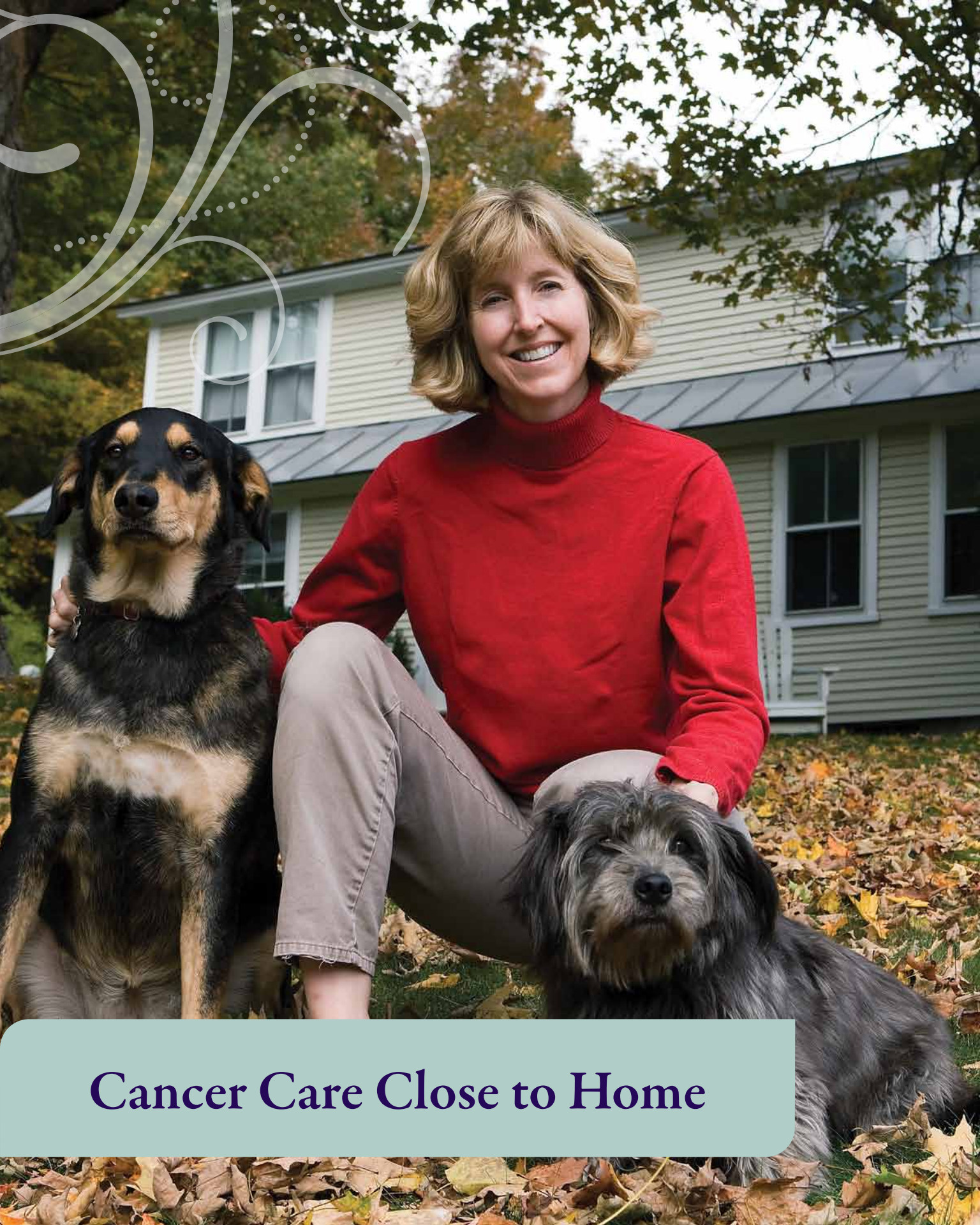

**Cancer Care Close to Home**

“Having had the personal experience, I now know how true the cliché is that a diagnosis of cancer changes one’s life. My experience began on Christmas Day 2007 when my mother noticed a mass in my neck. I was referred to the Endocrinology Department at DHMC where a needle biopsy revealed non-Hodgkins lymphoma in my thyroid. I was referred to the Oncology Department where I was seen by Dr. Marc Gautier. A friend told me he was an expert in dealing with lymphomas so I felt like I was in good hands from the very beginning. After a surgical biopsy and a bone marrow biopsy, I was scheduled for chemotherapy at New London Hospital. I didn’t know what to expect and was naturally apprehensive. Any fears I had vanished when I met nurse Melissa Nelson who was so kind and thoughtful, she put me at ease immediately. Melissa explained exactly what she was doing, what to expect from the procedure and patiently answered all my questions. I felt pampered; she offered me a blanket, something to eat or drink and did everything she could to make me feel comfortable. I was very impressed with the support offered by all members of the team.

During this time, I had appointments with Dr. Gautier at New London Hospital. Dr. Gautier always greeted me with a smile and he never made me feel rushed during my appointments. He consistently gave me the time needed to ask my questions and understand my prognosis. He has a wonderful manner about him that makes you feel he’s connecting with you and sympathizing with your situation. During the period of my three chemotherapy treatments, I was comforted by having friends and family join me during my sessions. Melissa was always available to talk with me.

After chemotherapy, I had 4 weeks of radiation at DHMC. I’ve had PET and CAT scans which show that my cancer is in remission. As I suggested earlier, this has been a life-changing experience that has made me realize what matters most in life. I’m very grateful to my family and friends and for the team at New London Hospital for helping me remain hopeful and positive.”

# Finding Solutions to Pain

“Recurring back pain was bothering me every day. It got to be non-stop. Running every day was hard, especially when I had to slow down because it was hard to breathe. Finally, I made an appointment to see Dr. Schissel at the Newport Health Center. He examined me and made a referral to the Pain Management Center at New London Hospital.

I was very pleased with Dr. Julie Franklin at the Pain Clinic. She explained everything to me in a manner I could easily understand. She went through various options to eliminate or alleviate my pain. She was very patient and answered all my questions. Because she wanted to rule out certain conditions, she scheduled me for a series of x-rays. The films showed slight scoliosis in my upper back. Dr. Franklin referred me for physical therapy where a misalignment in my hips was detected. I had 12 weeks of physical therapy, two to three times a week. After an interlude, I had an additional seven week course of therapy, two times a week. It didn't take long for me to see an improvement. When I saw Dr. Franklin in follow-up, she noticed a significant improvement. I was discharged from physical therapy but still have exercises that will maintain the improvement and keep the pain away. I've resumed my running and feel back to normal, thanks to Dr. Franklin and her thorough and caring approach to my care.”

**General Surgeons Offer  
Wide Spectrum of Care**

“A little over a month ago, I noticed pain in my abdomen. The next morning, I felt better and thought nothing of the pain. Shortly after, I was playing tennis when the pain returned and became increasingly more severe. I asked a friend to drive me to New London Hospital’s Emergency Department. Each bump in the road was a stab of pain. When we arrived around 5:00 pm, I was seen immediately by Dr. Kenneth Call who diagnosed appendicitis. A CAT scan revealed a ruptured appendix. I was in the operating room by 9:30 pm.

My surgeon Dr. Eberly was very caring and comforting. He listened carefully to all I had to say and explained everything in a manner that was easily understood. He quickly inspired confidence by seeming to know immediately what needed to be done.

I stayed in the hospital for two nights. The new private rooms were great and the nursing team exceptional. Dr. Eberly visited me and was pleased with my progress. In a follow-up appointment two weeks after surgery, I was told I could resume my normal activities. I’m happy to say I’ve resumed playing tennis. One usually doesn’t think of a hospital stay as a positive experience but I can honestly say that my time at New London Hospital was made as pleasant as possible by the excellent team of doctors and nurses.”

## A New Approach to Hip Replacement

“Eight years ago, I began noticing pain in my hip. It worsened until it reached the point where simple things like putting on socks or getting into a car became too difficult. Three years ago, a physician friend told me about the anterior approach to hip replacement. Since then, I’d been researching and studying this procedure.

Coincidentally, I saw an ad from New London Hospital about this new form of hip replacement. Dr. Gary Jones would be speaking and answering questions from the community. My husband and I took advantage of this opportunity and we were very impressed with Dr. Jones’ description of the surgery. He answered questions clearly and presented anterior hip replacement as an option for patients to explore with their physicians.

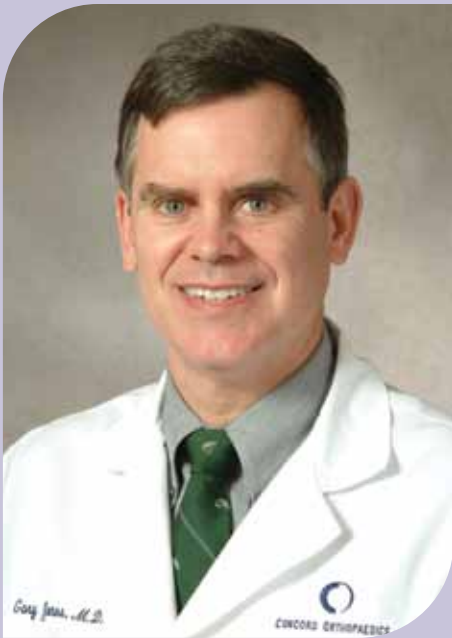
The day after the seminar I made an appointment to see Dr. Jones. An x-ray revealed osteoarthritis. Dr. Jones agreed I’d be a good candidate for anterior hip replacement and the procedure was scheduled.

Everyone I encountered at New London Hospital was wonderful. Those who conducted my pre-op testing, those who administered my anesthesia and the nurses who cared for me afterwards all made me feel I was in good hands. My surgery took about one hour and I stayed overnight. The next day, I actually walked to the nurses’ station without any assisting devices. I saw a physical therapist who demonstrated exercises which I tried with and without a cane. I was home by 2:00 pm.

My friends and visitors were amazed at my progress. I walked and exercised for two weeks, then went to see Dr. Jones for a follow-up appointment. I was discharged from his care and told that I could resume normal activities at a moderate pace. I experienced very little pain which was alleviated with aspirin or tylenol.

I’d ordinarily expect that this type of advanced surgery would be available only at big city hospitals. I was delighted to discover that our community hospital offers the finest in surgical advancements and quality care. We’re fortunate to be able to enjoy a rural lifestyle without sacrificing anything in the way of medical or surgical necessities.”

# Regaining Mobility through Rehabilitation



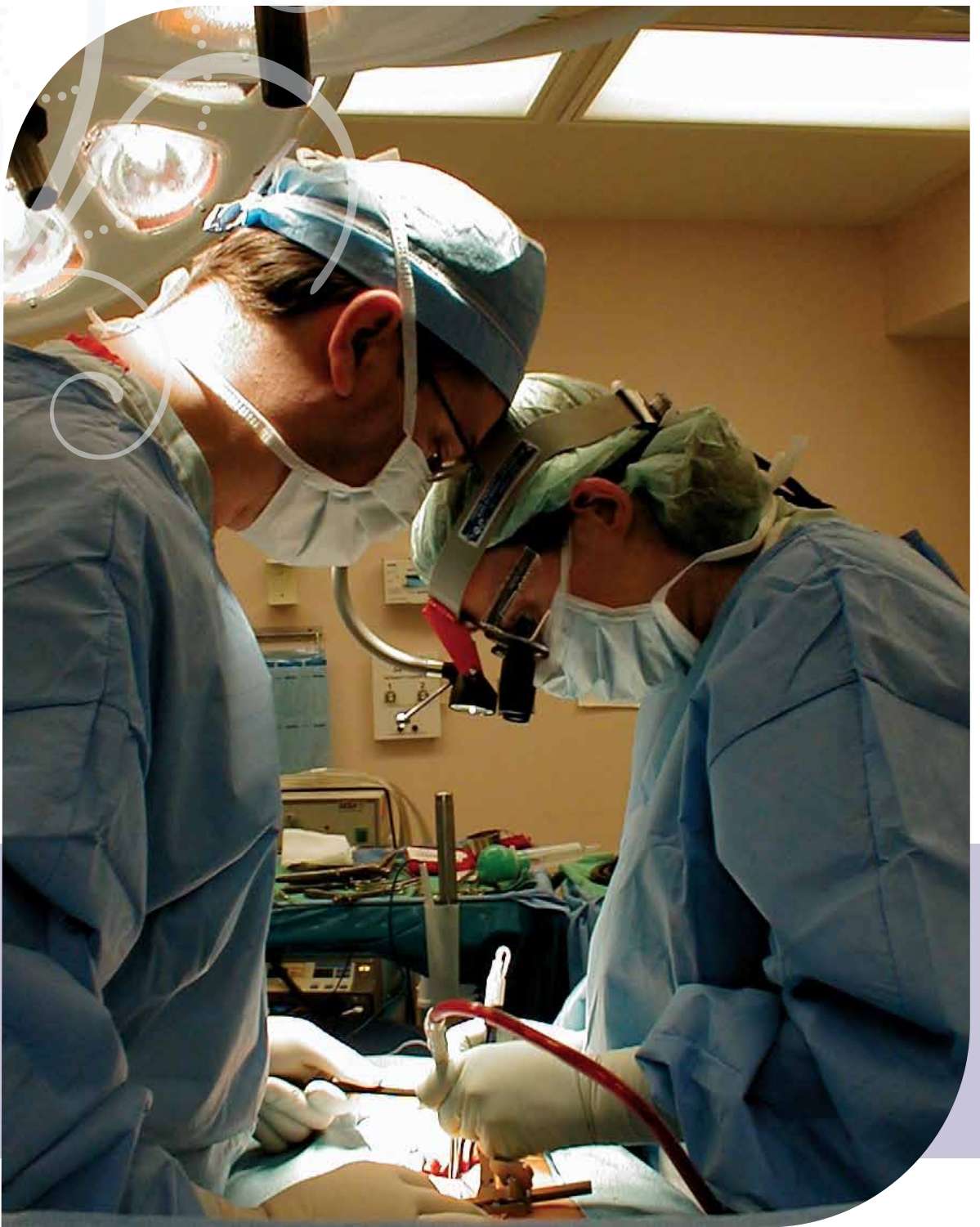

“I had surgery at New London Hospital for a pinched nerve. Dr. Hulda Magnadottir removed two vertebrae from my neck. Surprisingly, when I awoke, I was paralyzed on my right side. Before the reason was determined, I received physical therapy and occupational therapy. Patrick Laskowski and Matt Petrin helped get me moving. A barrage of tests and treatments then followed to determine the cause of my paralysis. These included intravenous infusions of steroids and MRIs. As it turned out, I had a bruise on my spinal cord. My surgeon said that a bruise is common when the vertebrae are removed but that it’s rare for paralysis to result. My tests revealed that I had Brown-Sequard syndrome, which is a rare spinal disorder that is usually caused by an injury to the spine in the region of the neck or back. Intensive inpatient therapy followed. When I returned home, I continued my rehab at the Newport Health Center. I had exercises to do every day and gradually saw improvements. I went from a wheelchair to a cane which I use mainly outdoors. My primary provider, Dr. Jordan, said that I exceeded his expectations. The people who cared for me at the Newport Health Center played a big role in helping me improve to such an extent. Patrick and Matt, along with Heidi Petrin, Frank Valente and Jeff Abrahamson, all worked with me and clearly answered all my questions. Under their care, I felt confident that I’d resume mobility to the extent possible. I was very glad the I was able to receive such great care close to home.”
